POLICIES & REGULATIONS

(Please read everything carefully)

The Santa Claus Parade committee does not wish to place many restrictions on a parade participant. The following policies are established as the minimum regulations for enjoyment and safety reasons. We require your cooperation in observing them. Parade participants are responsible for their own safety and the parade committee will not be held responsible for any accidents.

Requirements:

- 1. For 2025, all participants should incorporate A HOMETOWN CHRISTMAS theme in their decorations, music, float design and costumes.
- 2. All vehicles (including those towing floats and those used for promotional reasons) must be decorated.
- 3. Entries must be entertaining to a family audience, especially for children.
- 4. All participants must complete the Parade Registration Form and be at the Municipality office parking lot by no later than 4:00 pm.
- 5. Groups must stay together throughout the duration of the staging period and parade.
- 6. Chamber Volunteers will direct you upon arrival to your placement location. Please note the distribution of CANDY is allowed through a STREET WALKER.
- 7. NO HAND OUTS of literature, pamphlets, leaflets, brochures, flyers, coupons or any other written or printed materials to parade spectators.
- 8. There will be no premature exiting of the parade route, except in the case of a legitimate emergency.
- 9. Entries using music must play Christmas music.
- 10. No entry shall exceed 50 feet in length or 16ft in height.
- 11. Animal Entries: all entries are required to clean up behind their animals.
- 12. Name of group/entry must be prominent and easily identifiable.
- 13. Any entries using generators or other possible fire hazards must have a portable fire extinguisher of minimum class 3-A; 10-B; C.
- 14. Any floats with children must provide the following minimum Adult to Child ratio:
 - a. Children 12 and under 1:6 (one adult for every six children)
 - b. Children 13 to 17 1:12 (one adult for every 10 children)

Judging Criteria:

Judging is based on four categories. Each category is rated out of five for a total score of 20.

Effort – Adherence to the rules, theme, organization, and planning Theme – Adherence to the entry's chosen theme and effective presentation of that theme.

Appearance and Originality – Presentation, overall appearance, audience response, originality.

Participation – from the children and audience, and the group members enthusiasm.

Important Notices:

Each entry must identify a float captain who is responsible for reporting to a parade representative upon arrival at the gates.

All participants should arrive no later than 4:00 pm. Ensuring a prompt start to the parade.

Parade starts at exactly 4:30 pm (rain, snow, or shine).

End of Parade route: All vehicles must follow route provided by OPP and Central & North Hastings Chamber
